This appendix describes the overall public involvement program for the Columbia River Crossing (CRC) project:including a general description of public involvement activities that took place during the formal 60-day Draft Environmental Impact Statement (DEIS) comment period and specific public outreach efforts following publication of the DEIS. This appendix includes the program's goals for public involvement, a description of the public stakeholders targeted for involvement, and the outreach tools used to communicate with these stakeholders.

Through the public involvement program, CRC staff participated in more than 900 public events, leading to more than 27,000 face-to-face contacts to allow people to learn about the project and provide input. A list of all public involvement events held through summer 2011 is included at the end of this appendix. The program also enabled significant involvement for those who were unable to attend public events.

Extensive outreach has been conducted to a broad set of community audiences. The public involvement program supported the dissemination of project information in printed copy and electronic form through its Web site; attendance at fairs, festivals and community events; literature drops at key community centers; presentations to neighborhood, service and business groups; and presentations to community and neighborhood groups. The project's mailing list, used to encourage participation in public events and involve the broader community, has grown to nearly 5,900 email addresses and more than 14,000 postal mailing addresses. Diverse outreach techniques were used to reach low-income and minority populations through organizations that represent their interests, at locations in their communities.

The project engaged interested stakeholders and solicited comments and recommendations through topic- and geography-specific advisory groups; public open houses, design workshops and issue-specific public meetings; and ongoing opportunities to meet with staff at the project office, by phone, email and online comment and question submittal. CRC staff provided regular briefings to elected officials, boards, and civic leaders throughout the region.

Community input has shaped project development and design. Through implementation of the public involvement program, more than 12,000 public comments have been received on a range of topics. Public comments have significantly contributed to project designs, including the following topics:

Purpose and Need. The public, stakeholders and partner agencies provided comments that led to
the identification of project area problems, resulting in the CRC Purpose and Need Statement.
Community members contributed to the proposal of over 70 ideas as potential solutions for river
crossings, transit, freight, bicycles, pedestrians, roadways and transportation demand management.
Evaluation criteria were developed with a 39-member Task Force based on the Purpose and Need and
visions and values of the community.

- Preliminary Alternatives. Public feedback was encouraged on 23 initial river crossing ideas and 14 public transportation ideas and helped narrow the options to nine river crossings and seven transit ideas. These were combined into 12 multimodal preliminary alternatives to move forward for additional analysis.
- Environmental Impact Statement (EIS) Alternatives. As a result of three sets of open houses, numerous informational booths, meetings with community groups and ongoing meetings of the CRC Task Force, the project concluded the community supported solutions that improved the Columbia River crossing at I-5, added high-capacity transit to the project area, improved seven I-5 interchanges, improved bicycle and pedestrian connections and used transportation demand strategies to encourage alternative modes of transportation. The project team made a draft recommendation regarding project alternatives to move forward into the DEIS for further evaluation. Based on additional public testimony at public hearings in front of partner agency councils, the CRC Task Force voted to add alternatives that would reuse the existing I-5 bridges.
- Locally Preferred Alternative. The locally preferred alternative was selected following a 60-day public comment period on the DEIS. As a result of the outreach activities and community notification, the project received over 1,600 written or transcribed verbal comments about the DEIS. Comments received with the highest frequency were those stating a preference for one of the DEIS alternatives or options. The LPA consisted of three primary elements: river crossing, transit mode and transit terminus. Of the people who expressed a preference, the replacement I-5 bridges, light rail and the Clark College transit terminus garnered the most favorable comments. Prior to voting to recommend an LPA, the CRC Task Force received a summary of public comment and heard public testimony. Following the Task Force recommendation, each of the six local sponsoring agencies had hearings to receive public comment and then voted on an LPA recommendation. All six sponsoring agency boards and councils also recommended that a replacement bridge with light rail to Clark College be the LPA.
- Refinement of project designs. The project team has worked extensively with its agency partners, advisory groups, community stakeholders and the public to review, advance and refine aspects of the design for the locally preferred alternative. Project refinements that incorporate and reflect public feedback include the following:
 - Number of lanes on the bridge
 - Phased interchange improvements and re-use of North Portland Harbor Bridge
 - Marine Drive alignment
 - Bicycle and pedestrian pathway design and location
 - Urban design and architectural guidance
 - Hayden Island transit station design
 - Vancouver transit alignment
 - Vancouver transit station design
 - Local traffic bridge across North Portland Harbor
 - Columbia River bridge type

Please see Chapter 6 of this Final Environmental Impact Statement (FEIS) for a more detailed description of public involvement activities that occurred from publication of the DEIS through selection of the LPA (May 2 to July 2, 2008). Chapter 6 also provides an overview of comments received during the formal 60-day DEIS comment period. While public involvement on this project began much earlier, the National Environmental Policy Act (NEPA) public involvement program was formally initiated with publication of a Notice of Intent to prepare an Environmental Impact Statement (EIS) in the Federal Register on September 27, 2005, and continued through publication of the FEIS. Over the course of the project, this program was used to educate and involve interested parties and stakeholders in order to allow them to become active participants in shaping the CRC project.

Goals for Public Involvement

The goals for public involvement and measures for assessing progress toward these goals are as follows:

- Goal: Provide opportunities for meaningful public engagement in project development.
 - Objective: Keep the interested and affected people, groups, and agencies informed of project developments on an ongoing basis through presentations, attendance at community-based events, open houses, print and electronic communications, and the media.
 - Objective: Encourage public feedback though public outreach activities and tools.
 - Objective: Compile and summarize public feedback on an ongoing basis. Distribute public feedback to project staff on an as-needed basis.
 - Objective: Evaluate and consider all public comments.
- Goal: Fully comply with Executive Orders 12898 and 12948 on Environmental Justice.
 - Objective: Specifically target minority, low-income, and limited English-speaking populations within the project area for stakeholder outreach and feedback.
 - Objective: Translate project documents into Spanish, Russian, and Vietnamese, and provide interpreter services when needed.
 - Objective: Hold regular Community and Environmental Justice Group (CEJG) meetings and provide opportunity for feedback on key project decisions.

Stakeholders

The first major public involvement task was to identify who would be interested in, affected by, utilize, or otherwise have a stake in the CRC project; in other words, identify the public stakeholders. The following groups of people and organizations have been identified as public stakeholders and are the primary focus of outreach:

- The residents of Clark County, Washington, and Portland, Oregon
- People who live adjacent to I-5, in the project area
- People who drive on I-5, in the project area
- The business and freight community
- Transit users
- Media
- Low-income residents, minorities, and people speaking limited English (specifically those speaking Spanish, Russian, and Vietnamese), as identified in the 2005 demographic analysis for the Bridge Influence Area
- Neighborhood associations and community groups
- Elected officials
- Project sponsors and staff

Public Involvement Approach

The main focus of CRC participation in public events is at the grass-roots community level. The guiding philosophy is to take information and solicit feedback where people are already gathered, rather than expecting them to seek out project information and look for ways to provide input. To that end,

CRC staff continue to reach out to neighborhood associations on both sides of the river and seek to connect with other community groups, service clubs, business organizations, and large employers.

In Vancouver, targeted outreach is focused on the Esther Short, Arnada, Hudson's Bay, Shumway, Lincoln, Central Park, and Rose Village neighborhoods. In Portland, targeted outreach is primarily focused on the Hayden Island, Bridgeton, Kenton, and East Columbia neighborhoods, with close coordination through the North Portland Neighborhood Coalition office. These neighborhoods receive frequent visits and face-to-face outreach about concerns the neighborhoods may face as a result of being immediately adjacent to I-5 in the Bridge Influence Area (BIA). These neighborhood contacts have provided and continue to provide the CRC project team with valuable, localized community input. Project updates are sent to these groups through the City of Vancouver Neighborhoods office, the North Portland Neighborhood Coalition office, and the Neighborhood Association Coalition of Clark County. The project team also works with other associations across Portland and Vancouver to provide information and project updates, but not with the same frequency.

CRC staff have also reached out to individual businesses and business associations. Project staff met with groups such as the Uptown Village Association, Vancouver's Downtown Association, the Oregon Association of Minority Entrepreneurs, and the Portland Business Alliance. In addition, staff are engaged in an ongoing door-to-door outreach campaign to businesses near the proposed high-capacity transit alignments in Vancouver. These efforts have helped identify business-specific concerns and preferences.

The CRC project is complying with and exceeding NEPA requirements for public involvement, including fully complying with Executive Orders 12898 and 12948, which require each federal agency to make achieving environmental justice part of its mission "by identifying and addressing, as appropriate, disproportionately high and adverse human health or environmental effects of its programs, policies, and activities on minority populations and low-income populations." The project team has identified minority, low-income, and limited English-speaking populations within the project area for stakeholder engagement and sought additional feedback through establishment of a Community Environmental Justice Group (CEJG).

Public Involvement Tools

Listed below is a summary of the public involvement tools and methods used by the CRC project team.

Door-to-Door Outreach

Project staff used door-to-door outreach to reach businesses and residents at their homes or places of business to inform them about pending project decisions. This outreach was done in advance of decisions on the light rail alignment, before a hearing on the design of the State Route (SR) 500 interchange, and to publicize open house events such as those for the DEIS and light rail design workshops.

Fairs, Festivals, and Community Events

The project team focuses on reaching people where they are, on their terms and schedules, in order to connect with a broader range of people. These efforts include participation in local and regional community events such as Fort Vancouver Days, Ho'ike Hawaiian Festival, Sunday Parkways, Good in the 'Hood, concerts and events on the Portland waterfront, farmers' markets, and events targeted to people with a variety of ethnic and cultural backgrounds. These outreach opportunities provide the general public with an informal opportunity to engage with the project team, view project information, and learn about upcoming project milestones and public involvement opportunities. This type of outreach provides the public with increased knowledge of the project, a broad-based understanding of project

goals and schedules, and a convenient means of providing feedback directly to project staff. Project team participation at community events typically involves staffing informational tables.

Mailing List

A project mailing list for electronic and postal mail is maintained in a database for distribution of newsletters and electronic mailings.

Media Support

A media strategy is used to reach a broad audience with accurate and timely information, to increase awareness of the project by the general public, and to encourage attendance at public events. It includes methods for gaining media coverage at project milestones as well as methods to keep the project in the public eye between milestones. The following activities are employed to ensure that the media are appropriately involved throughout the project:

- News Releases: The project sends out news releases to the media distribution list to alert reporters and blog writers about major project milestones and public meetings. News releases are also posted online.
- Reporter Briefings and Materials: Members of the media receive project briefings at key milestones. At this time, they also receive press kits which include project descriptions, graphics, timelines, and key decision dates.
- Editorial Board Briefings: Editorial board meetings are scheduled with a variety of publications within Clark and Multnomah Counties in an effort to inform these boards and their reporters of the project.
- Opinion/Editorial Articles: Project staff solicit opinion/editorial articles from regional transportation leaders such as governors, legislators, local elected officials, the Secretary (Washington) and Director (Oregon) of Transportation, members of the State Transportation Commissions, business leaders, and others interested in transportation issues for submission to local papers.
- Minority and Small Press: Minority-owned and neighborhood-based media are included in the distribution of press materials. The project team has provided translated versions of press releases.
- Media Distribution List: The project maintains a media list and distribution system(s) to ensure that materials are distributed to all relevant and interested news outlets. Neighborhood publications and transportation-related blogs are included on this list.
- Community Calendars: Dates, times, and locations of community open houses and other public events are submitted to a wide variety of Community Calendar sections of publications (both inside and outside the project corridor) in order to reach a broad regional audience.
- Media Tracking: All print media stories are collected for reference and archiving and are distributed via email to key project team members on a daily basis.
- Email Messages: The project communications team keeps the media informed with monthly emails about the project.

Monthly Email Updates

Monthly emails are used to provide regular updates on the project status to all those on the project mailing list. The project's mailing list, used to encourage participation in public events and involve the broader community, has grown to nearly 5,900 email addresses.

Outreach to Limited-English, Low-Income, and Minority Populations

An important component of the public involvement strategy for this project is two-way communication with limited-English, low-income, and minority populations. To this end, the public involvement team coordinates with local communities and community-based organizations (CBOs) to develop appropriate strategies for outreach to these communities. The CEJG provided valuable feedback on outreach to limited-English, low-income, and minority communities.

Selected project documents are translated into Spanish, Russian, and Vietnamese; are posted on the project Web site; and are distributed in hard copy form at strategic locations in the community. Spanish, Russian, Vietnamese, and sign language interpreters are made available at project open houses upon request.

Using the translated materials, project staff have hand-delivered information to businesses along Fourth Plain Boulevard in Vancouver, where many Latino businesses are located, and along Sandy Boulevard in Portland, where many Vietnamese businesses are located. Staff have also used door-to-door distribution to inform many businesses in north Portland that cater to low-income and minorities about the DEIS comment period.

For more detail regarding outreach to environmental justice communities, please see Section 3.5, Neighborhoods and Environmental Justice, of this FEIS.

Printed and Display Materials

Printed materials provide information about the project to a broad range of audiences. One of the main components of the communications effort includes having a range of written materials that are easily identifiable as CRC materials that can be accessed either in print form or electronically. Individuals requiring reasonable accommodations can request written material in alternative formats or sign language interpreters by contacting the project team.

The following are all elements of the written materials that have been produced for the project:

- Newsletters: Project newsletters are produced to describe project plans and timelines, opportunities for public input, project options and alternatives under consideration, and project progress. They also serve as part of the notification system for public meetings and other milestones. Newsletters are also posted on the project Web site.
- Project Overview Fact Sheet: A general background document was created that describes project need, process, timelines, and benefits. This document is used for briefings and meetings and is updated as needed.
- Fact Sheets: Fact sheets have been developed that can be used individually or in packets for specialized audiences. These fact sheets focus on topics such as safety, transit, funding, and other topics of interest during project development.
- Display Boards: Display boards are created for open houses, booths at fairs and festivals, and miscellaneous presentations.
- Postcards: Postcards are mailed to relevant addresses approximately 1 to 2 weeks before public meetings. The address list may include all addresses in a particular area, all addresses in the project database, or a combination of both. These postcards notify neighbors and other interested parties of upcoming opportunities to review the project team's work and provide input.
- Presentation Materials: Presentation materials are prepared to support open houses, briefings with neighborhoods, business groups, and community organizations, as well as meetings with media and elected officials. Materials are tailored to each group and may consist of a combination of slides, illustrations, display boards, and presentation handouts.

Public Open Houses, Design Workshops and Issue-Specific Public Meetings

Public open houses and design workshops are held for the general public and special interest groups in coordination with key project milestones. Individuals requiring reasonable accommodations can request written material in alternative formats or sign language interpreters by contacting the project team. For the convenience of the public, these events are held in both Vancouver and Portland.

- In the fall of 2005, three public open houses were held to provide staff with public input to help define the primary problems in the project area. This information was relevant to the development of the project's Purpose and Need statement and helped generate ideas to address the identified problems.
- In the spring of 2006, two open houses were held to discuss and receive public feedback on 23 initial river crossing ideas and 14 initial public transportation ideas. Public input helped inform the project team's selection of ideas to move forward for additional analysis.
- In summer 2006, two design workshops were held with neighborhood leaders to discuss and receive public feedback on highway and interchange design options. Public input helped confirm the importance in the community of each of the highway access points in the project area.
- In late summer 2006, one open house was held to provide information and receive input on options for retaining or replacing the existing I-5 bridges. This open house was held in conjunction with a hearing by the U.S. Coast Guard on bridge options. Input received at this meeting helped inform a staff recommendation on which alternatives to move forward to the DEIS.
- In early 2007, four open houses were held to discuss and receive public feedback on the project team's draft recommendation regarding which alternatives should move forward into the DEIS for further evaluation.
- In the summer of 2007, three casual drop-in sessions were held to provide current information and receive feedback on bridge alignment options and high-capacity transit alignment options. As a result of these sessions, project area residents were kept informed about options being analyzed for the DEIS.
- In early fall of 2007, five meetings were held with potentially affected property owners to ensure they were informed about the project and introduce them to right-of-way staff. The primary purpose of these meetings was to share information and increase the level of communication between project staff and affected property owners.
- In the fall of 2007, two open houses were held to share new information and receive feedback related to project cost estimates and bridge and transit alignments. Public input from these meetings helped inform the ongoing analysis for the DEIS.
- In late 2007 and early 2008, three round-table discussions were held to share detailed information with neighborhood and business groups and transit-dependent populations about potential high-capacity transit alignments and streetscape design trade-offs, and to receive feedback. Feedback received was used by the transit team to inform future outreach and ongoing design.
- In the spring of 2008, two public hearings on the project's DEIS were held in conjunction with an informational open house. In addition, four informal question and answer sessions were held to allow people to comment on and to learn more about the DEIS. The public input received helped inform selection of the LPA and continues to inform the development of the FEIS.
- In the fall of 2008, two open houses were held to provide detailed information on several aspects of the project, including the number of traffic lanes, light rail alignment, and interchange improvements. The public was asked for comments on design and aesthetics of the bridge and transit and highway components of the project. The input received helped inform refinements of the LPA and the Project Sponsor Council's recommendation on the number of lanes on the replacement bridges.

- In early 2009, two workshops and a tour were held to share detailed information with the community about planning for light rail in Vancouver. Public input received helped inform the Vancouver Working Group's recommendations for alignment, park and ride design, and station location and design.
- In early 2009, two question and answer sessions were held to solicit input on a recommendation on the number of lanes on the replacement I-5 bridges. The input received helped inform the Project Sponsor Council recommendation in March 2009 on the number of lanes on the replacement bridges.
- In the spring of 2009, two open houses were held to share detailed information about the updated project design and to begin a more involved discussion about tolling. The events helped increase the level of community knowledge about tolling and ongoing design work and provided input on options for the Marine Drive interchange alignment.
- In the summer of 2009, three listening sessions were held by the CRC Tolling Study Committee (TSC). The TSC studied 10 tolling scenarios and gathered public feedback on tolling ideas for the project. Input from these sessions was included in the TSC's final report to the Washington Legislature.
- In the fall of 2009, one workshop was held to gain feedback on design guidelines for the Hayden Island light rail station. Input from this workshop helped inform the Portland Working Group's (PWG's) recommendations for the Conceptual Design Report.
- In early 2010, three open houses were held to share detailed information about light rail on Hayden Island and in Vancouver. The first open house focused on the improvements related to the proposed light rail station on Hayden Island. The second and third open houses focused on the proposed light rail alignments through downtown Vancouver. The first event helped increase the level of community knowledge about ongoing design work on Hayden Island and in Vancouver. Input received at the second two events helped inform the Vancouver City Council's decision on alignment.
- During the summer of 2010, three public meetings were held on Hayden Island to hear public testimony about access options for Hayden Island and to decide whether Hayden Island should be served by on-island or off-island access to I-5. The meetings helped a stakeholder group come to consensus and recommend a redesigned Hayden Island interchange. The redesigned interchange includes both on-island access to I-5 and a local multimodal bridge to Marine Drive.
- In September 2010, the project hosted an open house for construction contractors to receive input on procurement and contracting methods and specifications. The event provided an opportunity for contracting firms to get information about the project and informed future contracting and bid processes.
- In the fall of 2010, the project held two open houses on light rail station design. The first event was held in downtown Vancouver to gather input from the community about street configuration near the Fifth Street light rail station and the location of a park and ride in downtown Vancouver. The public input led to a decision to move the park and ride station across the street from the light rail station platform and to allow through traffic on Fifth Street. The second open house on light rail station design was held on Hayden Island and gathered input from the local community about whether to move forward with an elevated or at-grade station on Hayden Island. The input gathered led to a recommendation to move forward with an elevated light rail station.
- In late 2010 and early 2011, the project held meetings with property owners, who will be displaced or otherwise impacted by the project, to provide current information and explain the property purchase process.
- In early 2011, the project held listening sessions to present new information and receive feedback on bridge types being considered for the Columbia River bridge. Public feedback on the draft bridge type recommendation led to a decision by Governors Kitzhaber and Gregoire to move forward with the deck truss bridge type as the option to best meet multimodal transportation needs while also being the most affordable and presenting the least risk to budget and schedule overruns.

• In May 2011, the project held an open house about the historic and cultural resources within the CRC 5-mile study area. The purpose of this public meeting was to share information about the historic and cultural resources and to gather specific feedback on proposed mitigation for negative effects to the 1917 northbound I-5 bridge, Pier 99 building and Vancouver National Historic Reserve. CRC staff and partners presented the results of a study of the historic and cultural resources in the project area as well as proposed measures to offset identified impacts. CRC staff was available to receive comments, as well as record personal stories and scan old photographs related to the CRC project area.

Traveling Displays

Unstaffed traveling displays provide information on project context and highlight the range of feasible alternatives being considered. These display locations in Washington and Oregon rotate as needed.

Web Site

A CRC project Web site has been created and is regularly updated. The Web site provides project information, advisory group meeting schedules and materials, and schedules of public events. It also gives the public a means to provide the project team with feedback. At key project milestones, Web-based surveys are also available through this Web site. A major update to the project Web site was made in summer 2011. Changes improved site navigation and highlight frequently requested information. The new site design prepares the project for its transition from a planning phase to a delivery mode.

Broadcast/Podcast Information

In an effort to reach new populations and provide a new and convenient way for the public to stay updated about the project, the project team created and posted one podcast onto the project Web site.

Comments and Responses

Public and agency comments gathered over the course of the project are shared with selected project staff, based on project phase, issue, and area of responsibility. By attending outreach events, project staff (including technical staff) also receive comments directly from members of the public.

Each written comment (form, letter or email), outreach summary, record of telephone conversation with a member of the public, and transcript of testimony at a public hearing is logged into the public comment system so that it may be made available to decision makers.

Upon receipt of a comment, CRC staff determines if a question or comment requires a response. If so, staff researches the answer and responds to the questioner in about a week. More complex questions may take slightly longer to research. All comments and questions are then categorized (or delineated) by topic. Each comment can address numerous topics. At regular intervals, all the comments are summarized into a report. The report also contains information about recent outreach events and media coverage. The report is then distributed to project leaders, communications staff from project sponsor agencies, and some CRC advisory groups. All comments are available for review by any member of the public or project staff.

Communications Coordination

The communications team periodically convenes communications staff from the partner agencies to update them on project progress, introduce and review communications plans and messages, and track the distribution of project materials. Meetings are typically held around major project milestones or as needed.

Communications Tracking

The public can provide the project team with comments through a variety of methods, including email, the project Web site, voicemail, and public meetings. All comments and questions received are shared individually, or as summarized reports, with project team members and project partners, as appropriate. When appropriate, the project team provides timely responses to public questions or comments.

Advisory and Working Groups

The CRC Task Force was created to advise the Washington State Department of Transportation (WSDOT) and Oregon Department of Transportation (ODOT) on general project-related issues and concerns. After conclusion of the Task Force, the governors of both states appointed members to a Project Sponsors Council to advise staff on the further development of a locally preferred alternative. In addition, several community advisory and working groups were formed to address specific project issues as they arise. These advisory and working groups include specialists from agency and consultant staff and from other organizations. These working groups address public involvement, environmental justice, freight mobility, bicycle and pedestrian improvements, urban design, interchange alignment, and light rail design issues.

CRC Task Force

The Task Force met 23 times between February 2005 and June 2008 to advise WSDOT and ODOT on project-related issues and concerns. The Task Force adopted a Vision and Values Statement and a Problem Definition, which led to the approval of a project Purpose and Need Statement. Task Force members identified over 70 potential solutions and engaged in a multipart screening and evaluation process that was used to narrow options and package them into components for further study. The Task Force assisted with the evaluation of 12 preliminary alternatives and guided the development of the five alternatives presented in the DEIS. The final action of the Task Force was to make a recommendation on the locally preferred alternative.

The Task Force was composed of 39 leaders from a broad cross section of Washington and Oregon communities. Public agencies, businesses, civic organizations, neighborhoods, and freight, commuter, and environmental groups were represented on the CRC Task Force.

Project Sponsors Council

The Governors of Oregon and Washington formed the Project Sponsors Council (PSC), after the CRC Task Force sunsetted, to advise the departments of transportation on project development. PSC recommendations are made after considering technical information, receiving input from advisory groups, and reviewing public comments. As of June 2011, the council has met 22 times since 2008. This group is charged with advising the project on the following issues:

- Completion of the Environmental Impact Statement
- Project design
- Project timeline
- Sustainable construction methods
- Compliance with greenhouse gas emission reduction goals
- Financial plan

The council has made recommendations for the creation of a Mobility Council and Performance Measures Advisory Group, and has agreed with project advisory group recommendations for the number of bridge structures and the bicycle and pedestrian pathway location. Most recently, the PSC recommended a revised design for the interchange on Hayden Island, and that the replacement I-5 bridges have 10 lanes with full safety shoulders.

Pedestrian and Bicycle Advisory Committee

Specific Public Outreach Efforts Following Publication of the DEIS

Design Refinements in Late 2009

In June 2009, the CRC Project Sponsors Council (PSC) directed project staff to analyze the project for potential refinements that could produce cost savings while maintaining the project's environmental, economic, transportation, and safety benefits. Over a 5-month period, CRC project staff met with project sponsor technical staff to review potential refinements. The CRC project staff prepared a recommendation that was released to the media and presented to the Project Sponsors Council in December 2009 for consideration. The recommendation was reviewed at the CRC Freight Working Group, CRC Portland Working Group, and CRC Pedestrian and Bicycle Advisory Committee, and the members provided feedback. In addition, neighborhood leaders on Hayden Island participated in two meetings with CRC staff and ODOT leadership to provide input on the refinements package. At the PSC meeting, members heard testimony from dozens of people and asked for additional information to continue the discussion.

During public outreach, CRC staff heard the following:

- Support for reducing the overall cost of the project.
- Support for addressing CRC project purpose and need.
- Acceptance of reducing the number of lanes on the bridges and in the project area; although some people said additional reductions were needed.
- Acceptance of phasing improvements to the SR 500 interchange.
- Acceptance of phasing the Marine Drive flyover ramp by the freight and shipping industry, which would benefit from the improvement.
- Significant concern and some opposition related to reusing the North Portland Harbor bridges and lowering the profile of the highway on Hayden Island. These actions would result in the need to purchase additional property, including the property that supports the island's only grocery store and pharmacy.

As a result of comments and discussions related to Hayden Island, CRC staff continued to refine the design and increased the elevation back to its original level. Discussions are ongoing with island businesses about relocating grocery and pharmacy services.

In February 2010, the Governors of Oregon and Washington accepted the design refinement recommendations. They directed project staff to continue working with the community and to develop more detailed engineering designs using the recommended refinements.

Seventeenth Street Light Rail Alignment

The Vancouver Working Group considered various light rail elements, including alignment, from January to July 2009 in 12 public meetings. Members were evenly split on the selection of the east-west alignment between McLoughlin, which was analyzed in the DEIS, and 17th Street, which was not. Based on the lack of consensus, members of the Vancouver City Council and C-TRAN Board directed CRC staff in fall 2009 to thoroughly investigate both options and conduct additional public outreach.

The following public outreach was conducted:

- Held a public meeting for members of the Vancouver Working Group to inform them of the decision-making process and results of the technical investigation.
- Notified, with a mailer, the residents of 2,276 properties within a half-mile of the proposed light rail alignment options and invited them to upcoming open houses.
- Notified, with a letter, the 109 property owners and tenants (73 properties) with a description of proposed alignment, invitation to open houses, and the opportunity for a personalized meeting.
- Door-to-door outreach along light rail corridor options with alignment information, invitation to open houses, and an opportunity to set up personal meetings.
- Notified the general public about open houses via a news release distributed to the media. Resulting newspaper and radio coverage and information was posted on the project Web site.
- Held two light rail alignment open houses, that attracted a total of 90 people, to provide information about and collect comments on the alignment proposal.
- Participated in one-on-one meetings with more than two dozen potentially impacted property owners/tenants to inform them about possible property changes.

As a result of the outreach, CRC staff heard the following concerns, which were presented to the Vancouver City Council and C-TRAN Board before they voted to select the final light rail alignment:

- The loss of access and parking was the primary concern.
- Commenters were not opposed to the recommended configuration of station locations and traffic flow for the Washington/Broadway couplet.
- Property owners/tenants on McLoughlin Boulevard prefer a 17th Street route; while 17th Street property owners/tenants prefer a McLoughlin Boulevard route.
- The faster transit time on McLoughlin Boulevard was commonly offered as a reason for supporting light rail on McLoughlin Boulevard.
- The economic opportunities on 17th Street, due to vacant land and zoning, was commonly offered as a reason to support light rail on 17th Street.

Hayden Island Urban Design

The transportation problems on Hayden Island and potential community impacts have been among the top concerns of CRC officials. As a result, CRC staff and the community have participated in more than 81 meetings or events on Hayden Island from the beginning of CRC project development in 2005 through mid-2010. Total community attendance at these meetings topped 2,300 and allowed community input to inform project design.

The following types of public outreach occurred on Hayden Island:

- CRC open houses, design workshops, and drop-in question and answer sessions.
- Public meetings focused on the right-of-way process with people identified as potentially affected.
- CRC Portland Working Group meetings.
- CRC Community and Environmental Justice Group meetings.
- Hayden Island Mobile Home Owners and Renters Association meetings.
- Hayden Island Neighborhood Network (HINooN) meetings.
- Meetings with individual business and property owners.
- Postcard mailings to all residents to advertise open houses and workshops.
- Demographic surveys of floating home and manufactured home facilities.
- Unstaffed information kiosk at Jantzen Beach SuperCenter.
- CRC participation in ODOT open houses on Interchange Area Management Plan.
- CRC participation in City of Portland-sponsored effort to develop the Hayden Island Plan.

As a result of ongoing conversations, CRC has heard:

- Implement the vision of the Hayden Island Plan.
- Fix the I-5 bridges and highway congestion.
- Maintain access to I-5 via a Hayden Island interchange.
- Bring light rail to the island.
- Avoid impacts to businesses, especially Safeway.
- Improve east-west connections.
- Reduce local traffic back-ups on the island.
- Improve bicycle and pedestrian pathways.
- Avoid impacts to homes.
- Reduce/limit construction impacts (noise, vibration, traffic, dust, emissions).
- Encourage investments that improve quality of life.
- Identify residents in the manufactured home community and Jantzen Beach Moorage as environmental justice populations because many are low income.
- Create transportation links on the island that have ample natural light and are safe and inviting to pedestrians and bicyclists.
- Use surface mail and face-to-face meetings to inform Hayden Island residents of project updates or events.
- Provide more detailed information.

With this feedback, CRC:

- Provided regular updates about project design refinements at community meetings.
- Designed a new east-west connection on the island and modified its design based on additional community input (this design was referred to as Concept D).
- Included direct connections to Marine Drive that do not require drivers to merge into highway traffic.
- Designed improvements to local roadways that include wider sidewalks and bike lanes.

- Committed to converting some private roads into public ownership and maintenance.
- Designed a new light rail transit station.
- Increased the frequency of meetings with island residents.
- Designed the Hayden Island interchange to separate local traffic from highway ramp traffic and substantially improve its safety.
- Designed improvements to I-5, the bridges, and light rail so they support the vision in the Hayden Island Plan.
- Worked to reduce property impacts to the least number possible.
- Committed to working closely with the island community for the long-term.

Lower Downtown Vancouver Station Area Design

Based on questions raised by local business and property owners in the summer of 2010, CRC, City of Vancouver, and C-TRAN staff began re-examining the existing transit designs for lower downtown Vancouver with a goal of improving the connections to the surrounding area. New proposals were developed and shared with the community.

The following outreach was conducted in downtown Vancouver:

- Door-to-door outreach to local businesses and property owners.
- Mailed open house information to the residents and property owners of 7,200 properties in adjacent areas.
- Held a public open house in downtown Vancouver (that attracted 103 people) to hear feedback on design options for the light rail station area south of 7th Street in Vancouver.
- Notified the general public about open houses via a news release distributed to the media.
- Sent an email to all surrounding neighborhood associations to invite them to the upcoming open house.
- Contacted and set up one-on-one meetings with Vancouver property owners affected by the light rail alignment.

CRC staff heard the following from the public:

- Commenters were evenly split on their preference for a park and ride location either inside or outside of the SR 14 interchange.
- Most commenters preferred an open 5th Street configuration because it better served local businesses, facilitated movement in downtown for all modes of transportation, and better connected areas of downtown Vancouver.
- Station design is critical and should reflect community values such as safety, accessibility, and visual aesthetics.

The City of Vancouver and C-TRAN reached a decision to have an open 5th Street configuration with the park and ride located outside of the SR 14 interchange.

Hayden Island Interchange Design

In 2010, the community and members of the CRC Project Sponsors Council agreed that the existing Hayden Island interchange design needed adjustment to better address residents' goals for access and livability. A Hayden Island Design Group (HIDG) was formed to incorporate the perspectives of island residents, business owners, City of Portland, and Metro.

The following public outreach was done:

- News releases (nine) were sent to the media to announce meetings, open houses or decisions related to the Hayden Island interchange.
- Three open houses with public testimony were held on Hayden Island to hear feedback about the concepts being developed for the Hayden Island interchange. The open houses also included information about other recommendations being considered at the same time.
- Postcards were mailed to 2,100 recipients, including all businesses and residences on Hayden Island and in the Bridgeton and Kenton neighborhoods. The postcards included information about each of the open houses on Hayden Island. Postcards were mailed to an extended group for the third open house where additional recommendations were being presented.
- The Portland Working Group met publicly and made recommendations on the concepts being considered for the Hayden Island interchange.
- Public meetings were recorded by CVTV, and links to the coverage were posted on the CRC Web site.
- Web pages for each public meeting were created to host meeting materials for people who could not attend the meetings.

As a result of the public outreach, the CRC project was able to:

- Engage 372 people at three public meetings on Hayden Island.
- Develop four Hayden Island interchange concepts for public review.
- Receive consensus from the public, Hayden Island Design Group, Portland Working Group, partner staff and PSC on moving a revised Hayden Island interchange concept forward as the preferred interchange design (referred to in this FEIS as LPA Option A).

Bridge Type and Architecture

In 2010, CRC convened a Bridge Review Panel to evaluate the bridge type under consideration for the project. In February 2011, the panel released a report that offered three feasible bridge type options for consideration that panelists found to be less expensive and more suitable for the crossing over the Columbia River than the bridge type under consideration at that time. The governors of Oregon and Washington responded to the panel's report by asking their respective departments of transportation to conduct an expedited review of the three bridge types and make a recommendation considering affordability, project schedule, environmental impacts, commitments made to stakeholders and risk. Based on these criteria, the states conducted further evaluations and made the draft recommendation of a deck truss bridge type for the crossing.

The following public outreach was conducted:

- Stakeholders, project advisory committees, project sponsors staff, local elected officials and the public were asked to review and comment on the proposed deck truss bridge type.
- Advisory groups and the public were presented the final report and recommendations of the Bridge Review Panel by the panel chair.
- Project advisory groups were convened to gather feedback on the draft bridge type recommendation.
- Two public listening sessions were held in Washington and Oregon for the public to provide comments directly to the PSC Co-Chairs, the CRC Director for Washington and the Oregon Director of Transportation.

Public outreach resulted in over 290 comments online and in public sessions that generally fell into three categories:

- Support for the departments' recommendation and importance of making a timely decision
- Support for the deck truss bridge type
- Support for the cable-stayed bridge type

Support for the cable-stayed alternative centered almost exclusively on aesthetics—supporters found it a more attractive design and thought that aesthetics should have been a prominent criterion in the departments' review and draft recommendation. Proponents of the cable-stayed bridge type focused most of their critique on the departments' findings that the deck truss was the only bridge type that could maintain project schedule.

After reviewing many different factors, the governors found the deck truss bridge type to best meet multimodal transportation needs of the project while also being the most affordable and presenting the least risk to budget and schedule overruns. As the deck truss bridge type can maintain the current CRC project alignment and footprint, the deck truss bridge type would also have no significant additional environmental impacts. The governors identified in their recommendation the need to add an architect to the project team, establish architectural specifications for the design build contractor to follow, and to engage the design community and public in the process.

Section 106

CRC has continued to follow the appropriate steps for identification and evaluation of historic and archaeological resources and determinations of adverse effects related to Section 106 of the National Historic Preservation Act.

The following public outreach was conducted:

• CRC held an open house about the historic and cultural resources within the CRC 5-mile study area. The purpose of this public meeting was to share information about the historic and cultural resources and to gather specific feedback on proposed mitigation for negative effects to the 1917 northbound I-5 bridge, Pier 99 building and Vancouver National Historic Reserve. CRC staff and partners presented the results of a study of the historic and cultural resources in the study area as well as proposed measures to offset identified impacts. CRC staff was available to record personal stories and scan old photographs related to the CRC project area.

Comments included a desire for tools to educate the public about the area's history, such as a museum. This is consistent with project mitigation that includes providing funding to build a new curatorial and museum facility at the VNHR.
