SUBJECT: Development Division Use of Electronic Signatures

With the passage of the Uniform Electronic Transaction Act and a forthcoming executive order, it is necessary to provide a permanent policy outlining acceptable means for applying electronic signatures (formerly called digital or electronic signatures) as part of Development Division's ordinary business practices.

This policy applies only to documentation under the Development Division's purview. There are other documents that we sign or approve (i.e. receipts for reimbursement, position descriptions, travel vouchers, etc.) that are under the purview of other WSDOT Divisions (Human Resources, Accounting). These documents should be processed electronically under the guidance provided by those Divisions.

Policy

Electronic signatures are considered acceptable forms of signatures on all documents. Electronic signature is defined as a symbol or process attached to or logically associated with a record and executed or adopted by a person with the intent to sign the record.

For this policy, electronic signature types are classified as shown in Table 1 and Table 2. Table 1 shows types of electronic signatures that are non-validated and Table 2 shows types of electronic signatures that are validated.

The risk level of a document is determined by Region, Program, or Department leadership. It is expected that the risk level will reflect the risk levels used prior to the implementation of electronic signatures.

For low-risk documents, use any type of non-validated signature. Examples of these documents are manuals, letters, memos, or formal correspondence.

For an average risk document that requires approval or concurrence (internal or external), use a non-validated signature type that is self-certified. Examples of these documents are:

- Basis of Design
- Right of way certification
- Consultant agreements and amendments
- NEPA documents
- Interagency agreements

Some average risk documents require a professional stamp. These documents may also use a non-validated signature type that is self-certified. Examples of these documents are:

- Design Analysis
- Maximum Extent Feasible
- Hydraulic reports
- Traffic analysis
- Structural calculations and reports
- Structural special provisions

For documents considered high-risk or high-value, use third-party authentication via a cloud service like Adobe Sign, DocuSign, or a remote notarization program. These services have a cost, so limit their use to documents that must have solid confirmation of the signer's identity. The level of validation (e.g. email only, password, two-factor authentication, etc.) can be set by the manager of the process. Examples of these documents are:

- Real estate leases, contracts deeds, and other recorded documents
- Notarized documents

For plan sets, the WSDOT has worked with the Board of Registration for Professional Engineers and Land Surveyors to determine how WSDOT plans requiring professional stamps can be delivered electronically in compliance with WAC 196-23. This direction is captured in Project Delivery Memo #21-02 and will be incorporated into the 2022 version of the Plans Preparation Manual.
